In this spirit, we encourage you to propose innovative creations and, above all, to avoid the commercialized products found all over the world, which have transformed kite events into amusement parks.

All creations are welcome, provided they were built by the kite flyer or are of specific interest.

A creative competition will be held on the theme of "ASYMMETRICAL BALANCE".

The creations will be presented in advance in the Creative Workshop area and submitted to the public for judgement.

Judging will be provided by experienced kite flyers during the launch of the creations on **Saturday, September 20th**.

A night flight is scheduled for Saturday, September 20th, starting at 10:00 PM, as a thank you to the city for hosting the event.

In accordance with Articles 15 to 22 of the General Data Protection Regulation (GDPR – Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016), each participant has the right to access, rectify, delete, restrict, or object to the processing of their personal data.

# Rules and conditions for participation

In order to register for this new edition of Dieppe International Kite Festival, you must read and accept the rules and conditions of the event.

# Please be aware that your applications and requests must be sent BEFORE THE 01/08/2025.

We draw your attention to the fact that NO REGISTRATION will be considered after this date.

### Conditions

1 - The presence of commercial brand names in the enclosure of the festival is prohibited.

2 - In order to obtain a car pass, you must justify the necessity beforehand with the festival organizers. Please note that no pass request will be considered during the festival.

3 - Access to flight areas: access to flight areas is subject to registration with the festival organizers. Only people wearing a badge are allowed to enter. Participating kite flyers must respect the marked flight areas reserved for them as well as the flight times. The Festival rejects any responsibility towards the persons who do not respect the areas and flight times indicated and authorized by the organizers. People not respecting these instructions do so under their own responsibility.

4 - On the site, banners, wind structures and folding chairs are allowed but these should not obstruct the public's visibility or circulation.

Not allowed:

- tents and tables (regardless of size),

- alcoholic beverages,

- dangerous objects,

- any other object or structure that may alter or interfere with the proper functioning of the flight areas.

The use of drones is STRICTLY FORBIDDEN during the Festival.

5 - Parking near the village is your responsibility. In case of damage to your vehicle during the event, no claim may be presented to Festival organizers.

Camper vans: by municipal decree of 11/04/2002, the parking of camper vans is forbidden on the seafront. Payable parking is provided at the entrance of the seafront and Quai de la Marne. For more information contact the Office de Tourisme Dieppe-Maritime (+33 (0)2.32.14.40.60).
